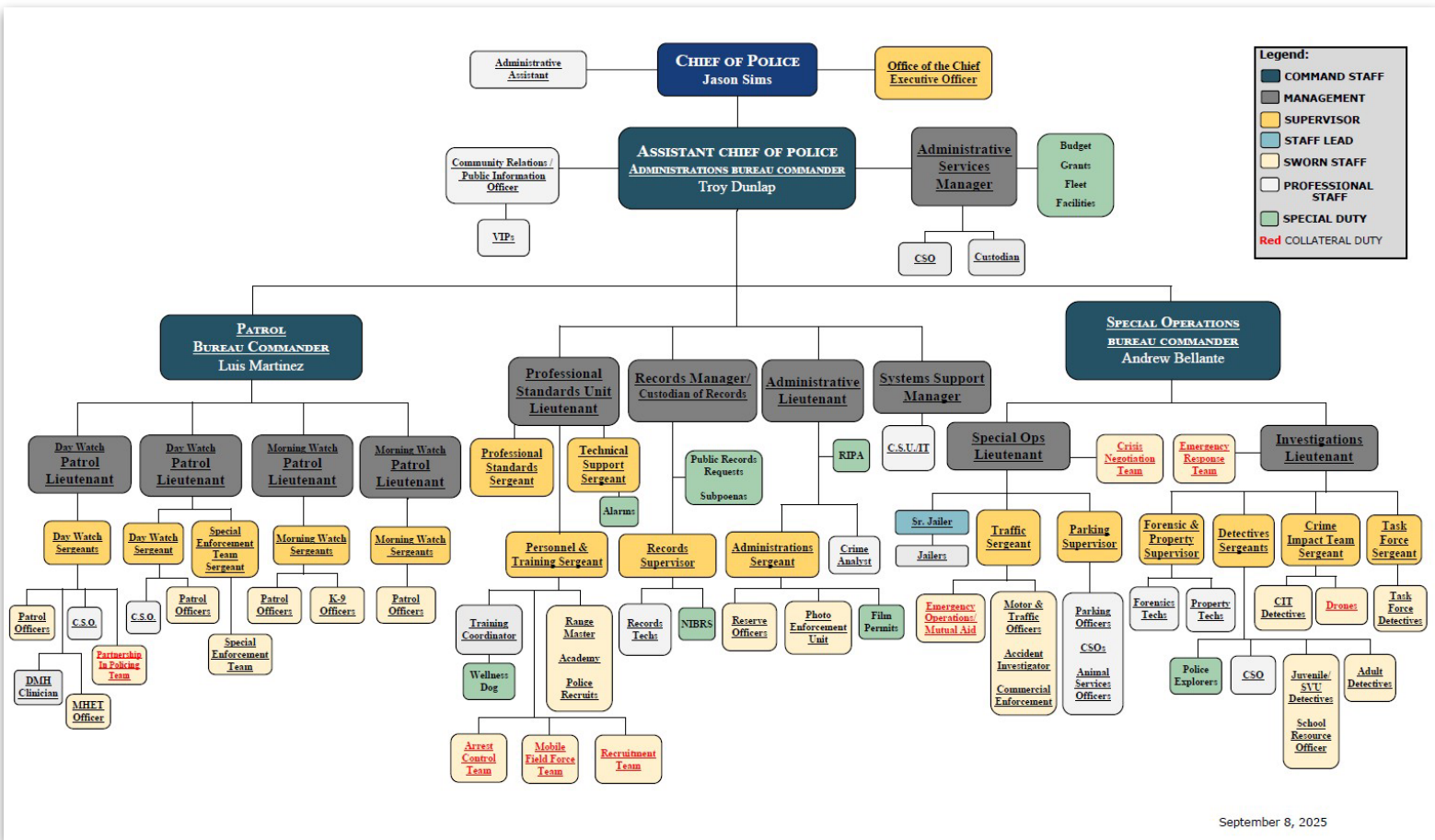

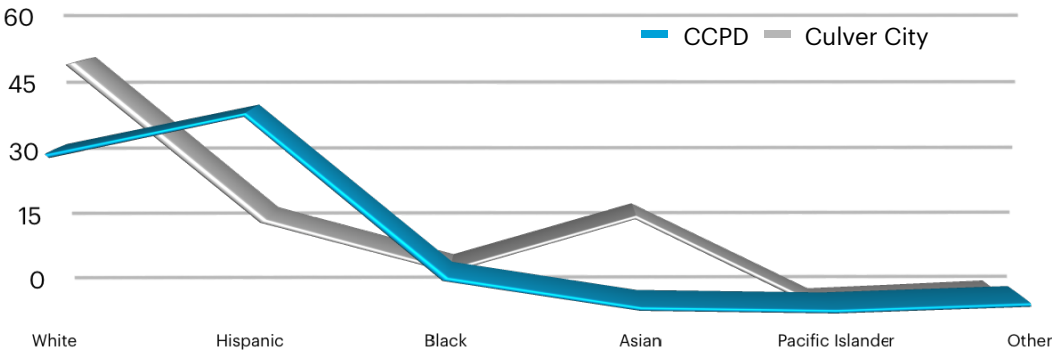

Demographics of Police Department vs. Culver City Population

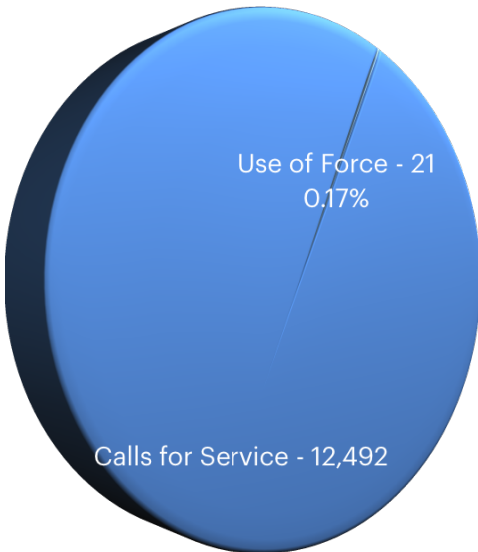
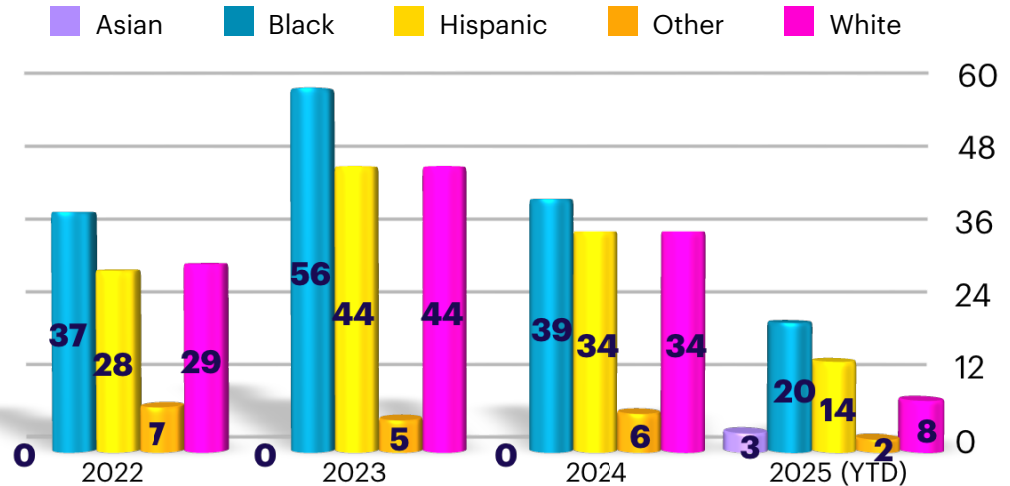

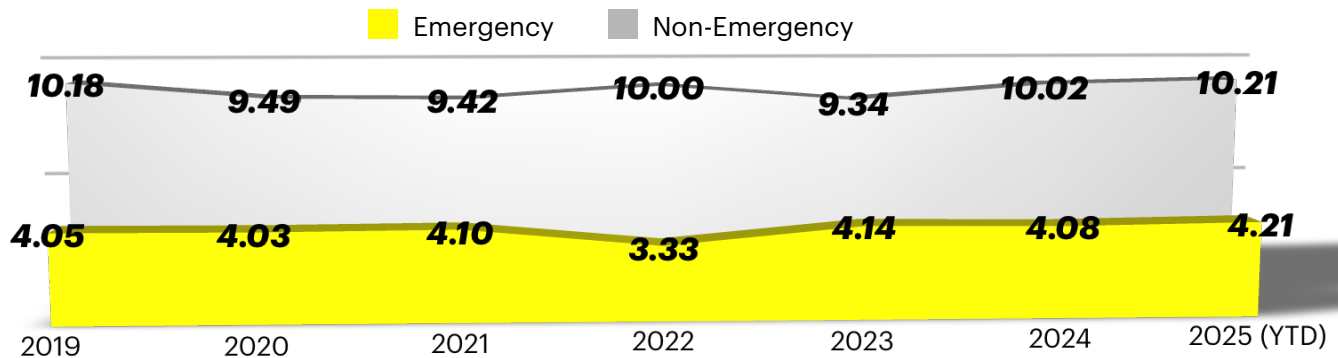

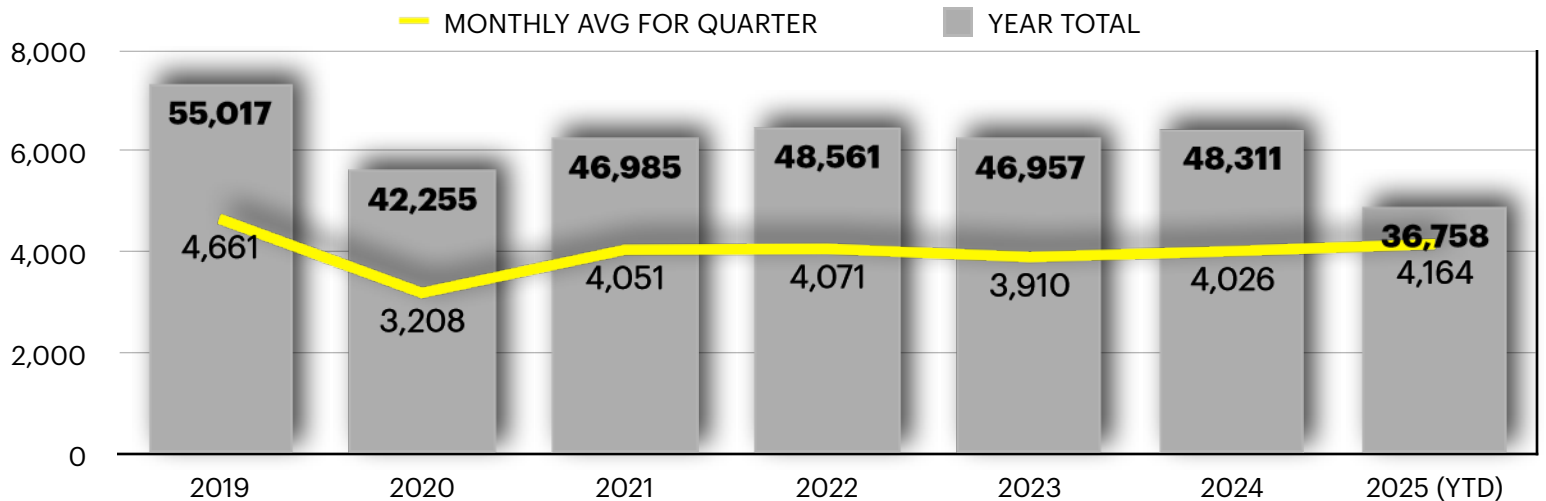

**Overall Average Response Time for 2025 (YTD)****Calls for Service**

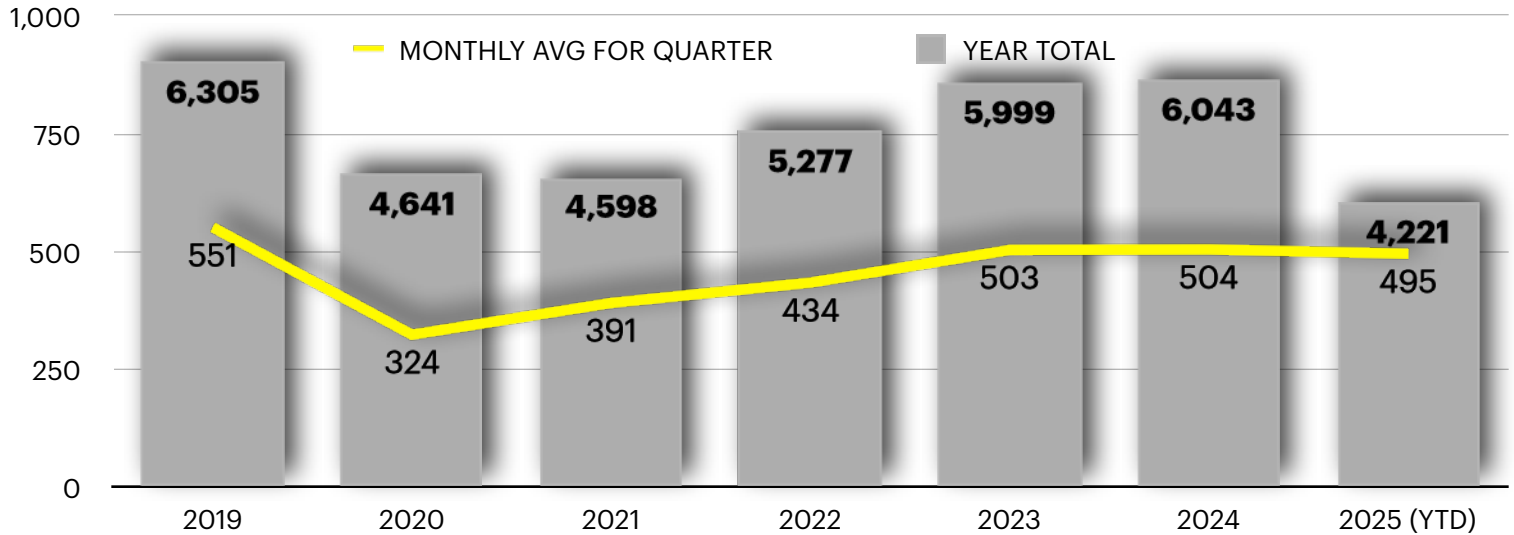

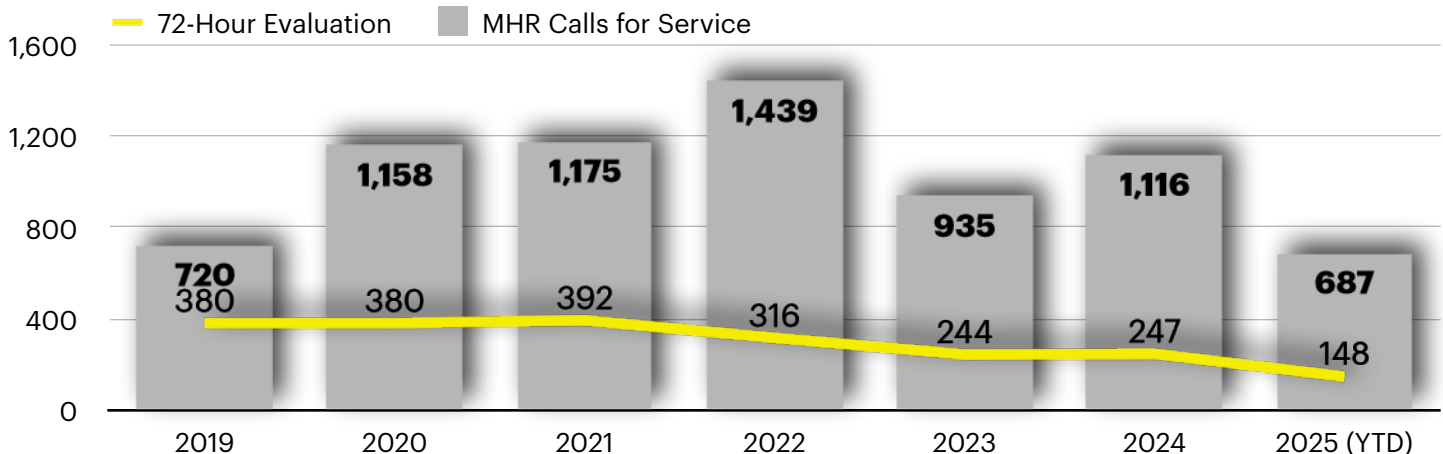

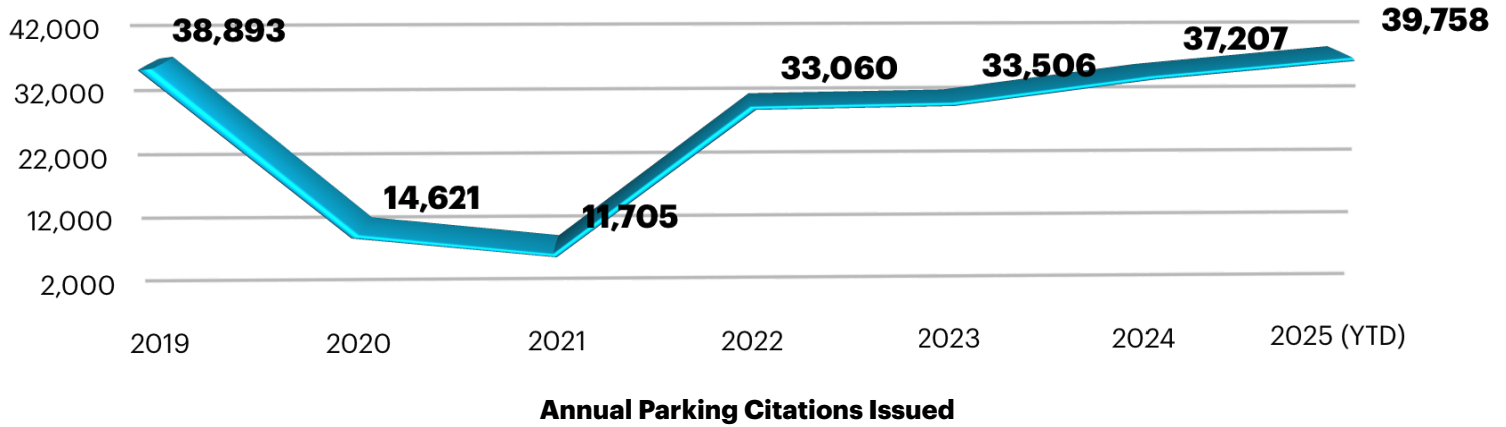

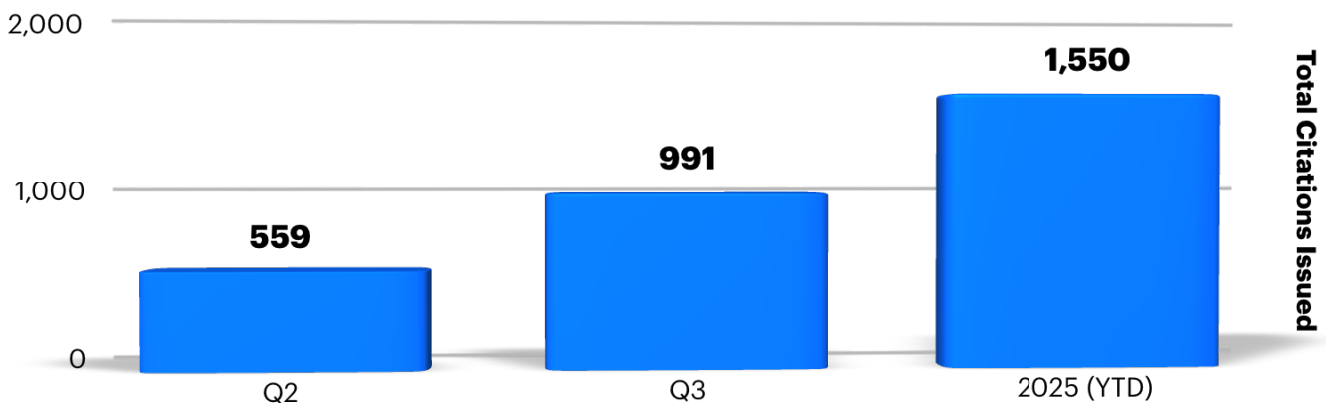


## **Automated Bus Lane Enforcement (ABLE)**

This section contains data related to Culver CityBus's Automated Bus Lane Enforcement (ABLE) program. This program uses cameras on buses to detect and enforce violations in bus lanes and at bus stops, improving transit safety and reliability. The data collected includes information about violations, bus locations, and real-time arrival and departure information.

The ABLE program launched on May 19, 2025 and equipped cameras on 10 Culver City Transportation vehicles—including buses and shuttles.

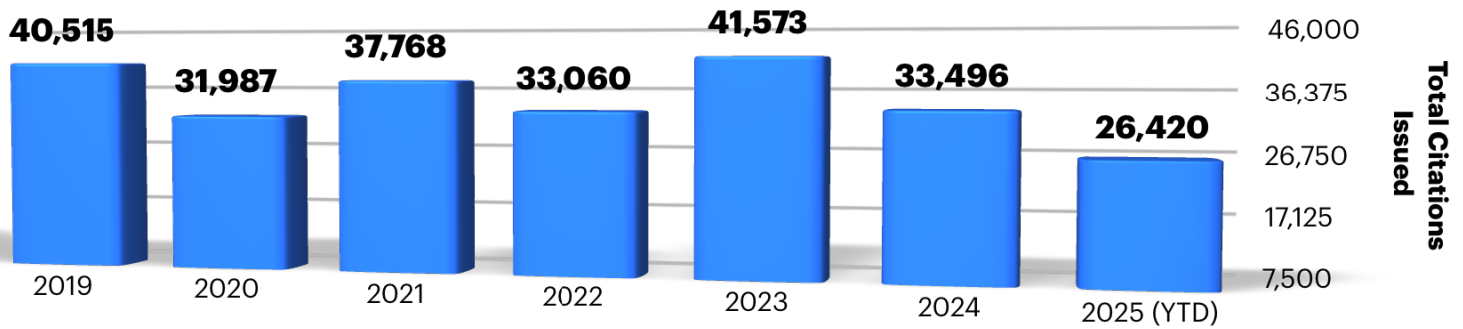




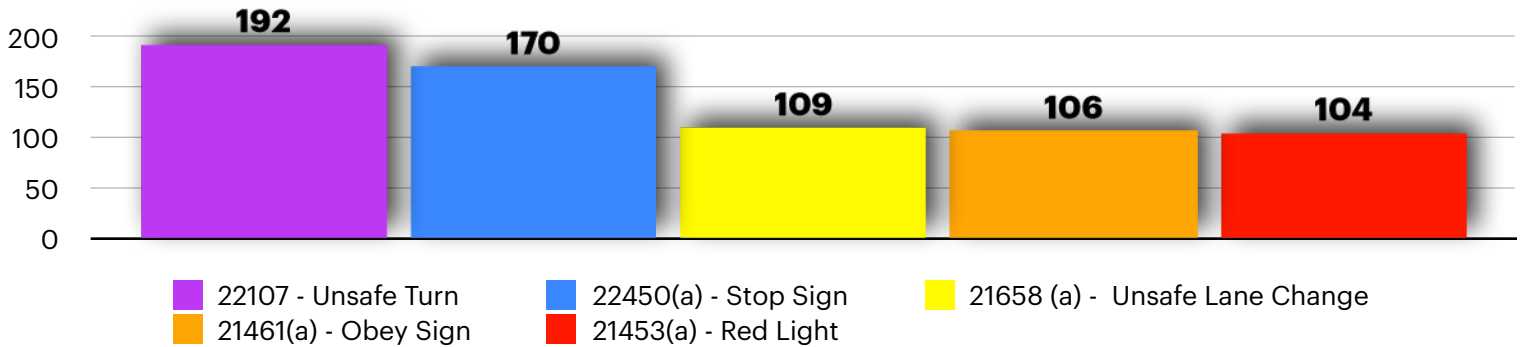

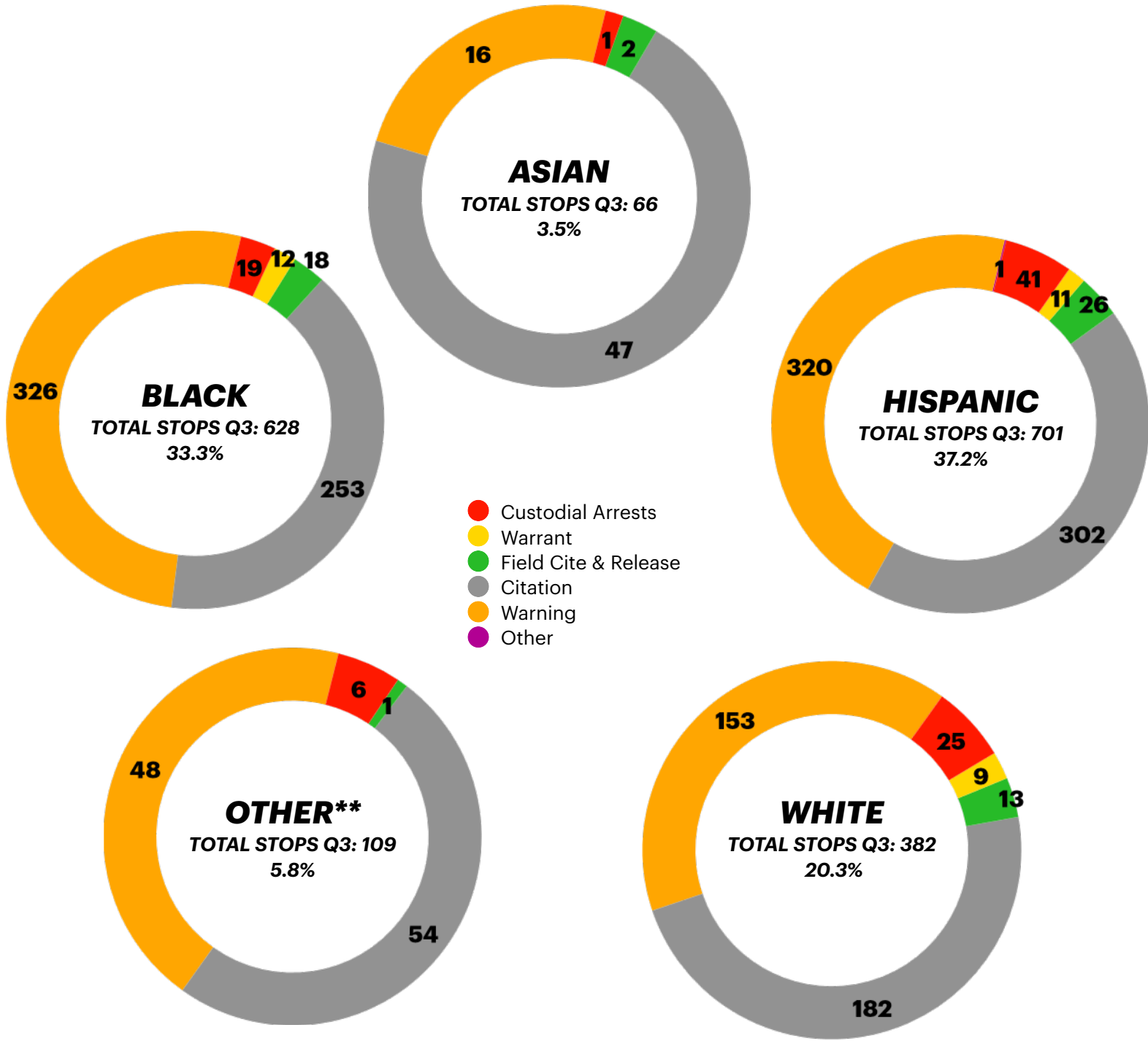


## **Racial Identification and Profiling Act (RIPA)**

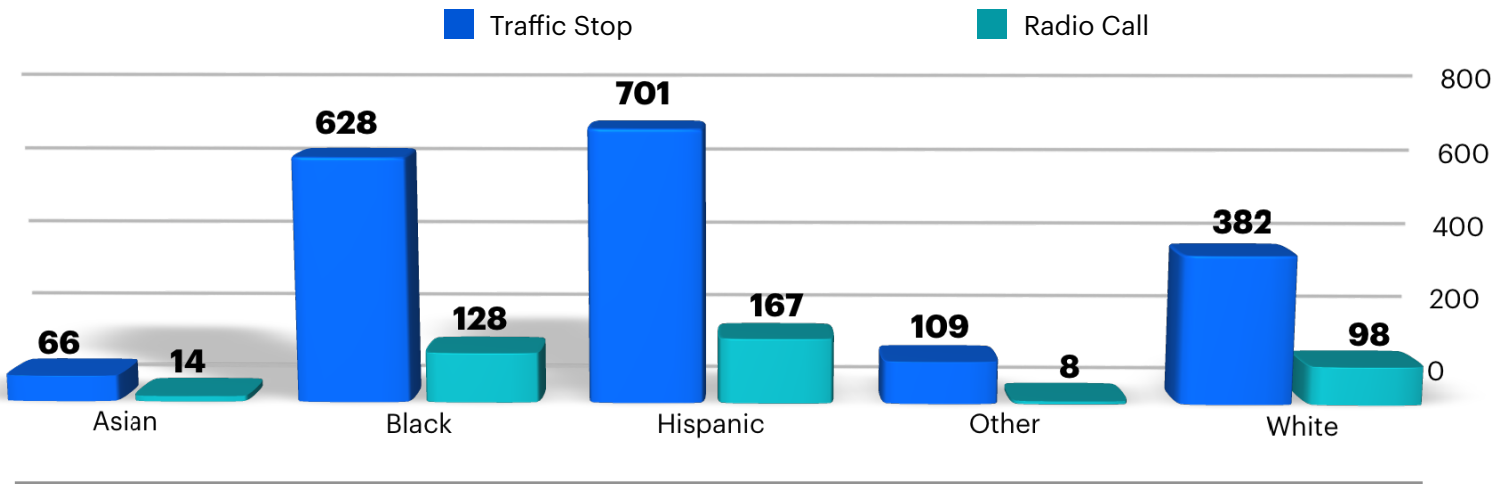
## **Traffic Stop Detentions & Results (by Race)**

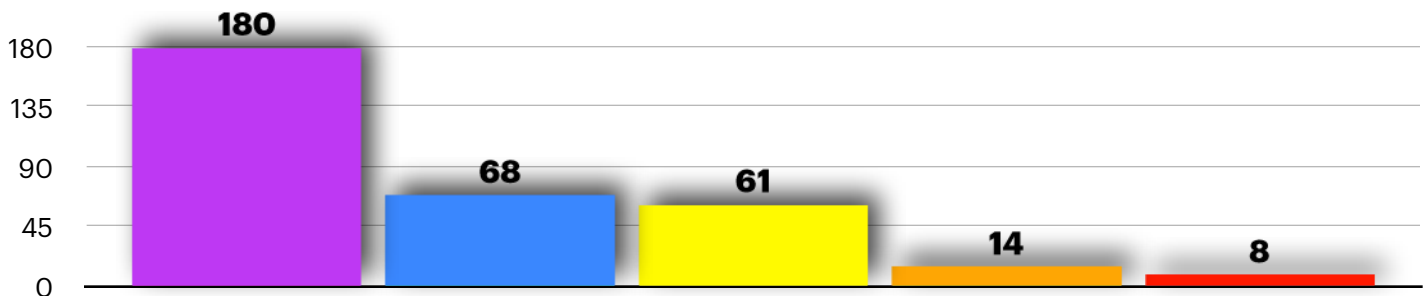

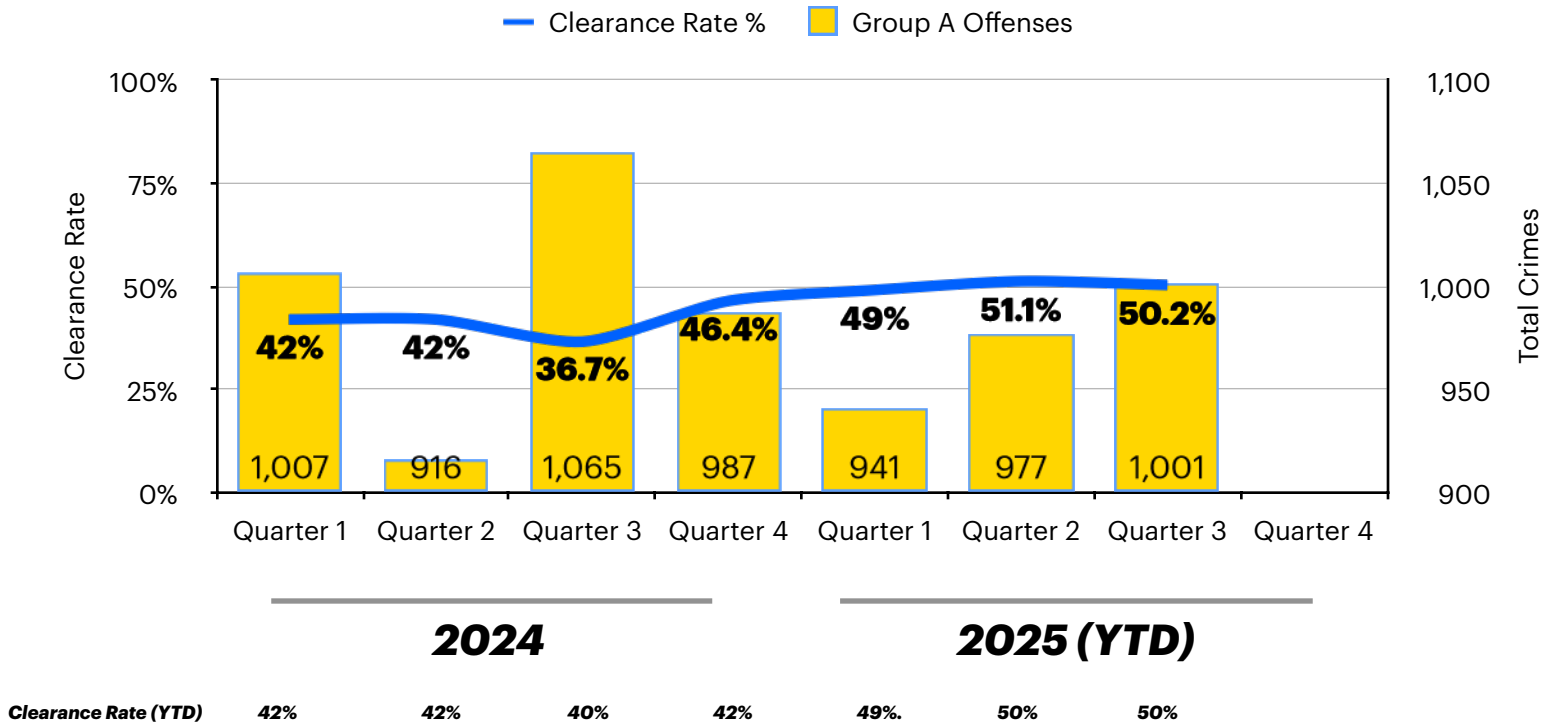
## SPECIAL OPERATIONS BUREAU

*\*Beginning March 1, 2021, the Culver City Police Department implemented the National Based Incident Reporting System (NIBRS) to improve the overall quality of the crime data collected. NIBRS provides the circumstances and context for crimes in more detail than the traditional Summary Report System (SRS). As of January 1, 2021, the Federal Bureau of Investigation (FBI) made the nationwide implementation of NIBRS a top priority to provide more useful statistics to promote constructive discussion, measures and informed policing. NIBRS establishes a new baseline that more precisely captures reported crime in a community.*

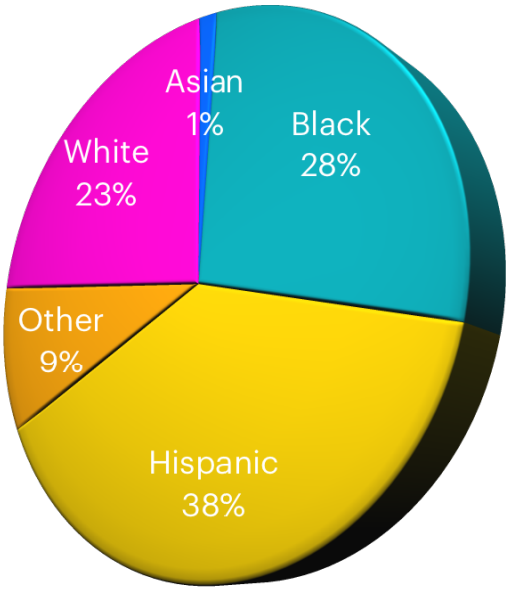

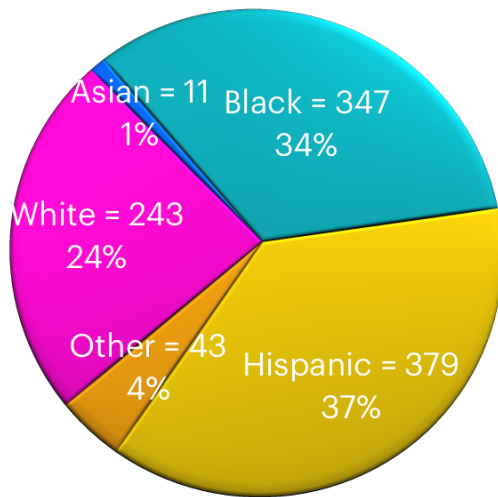

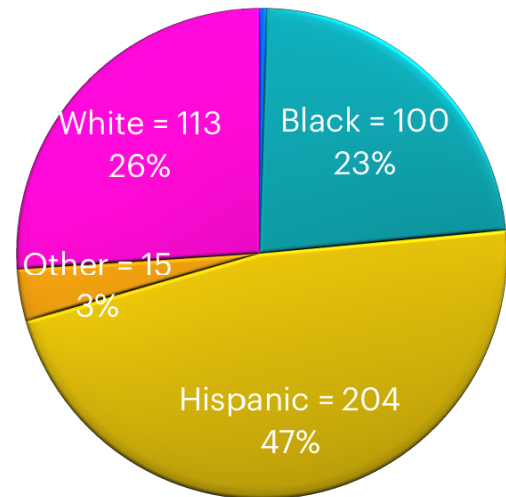

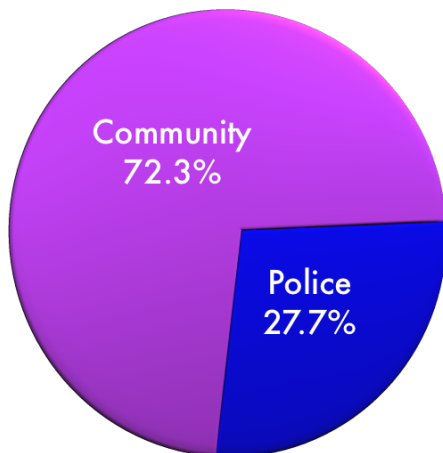

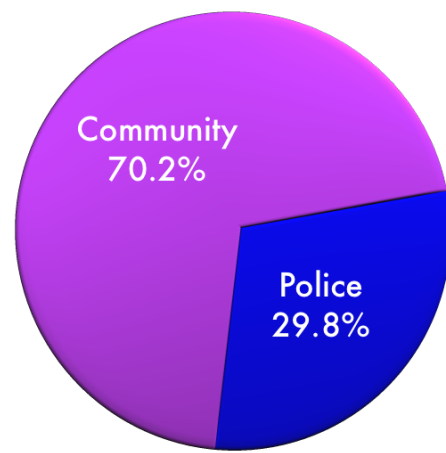

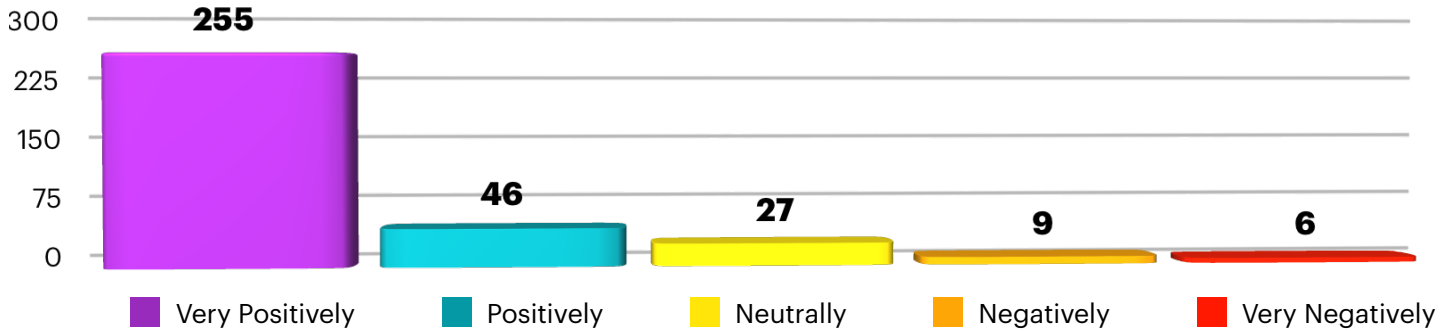
## My90 Summary

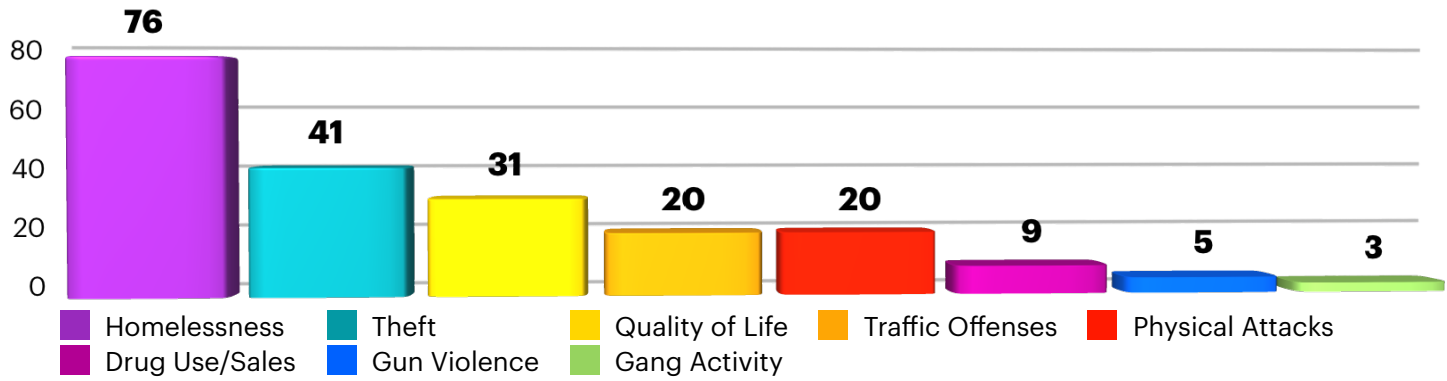
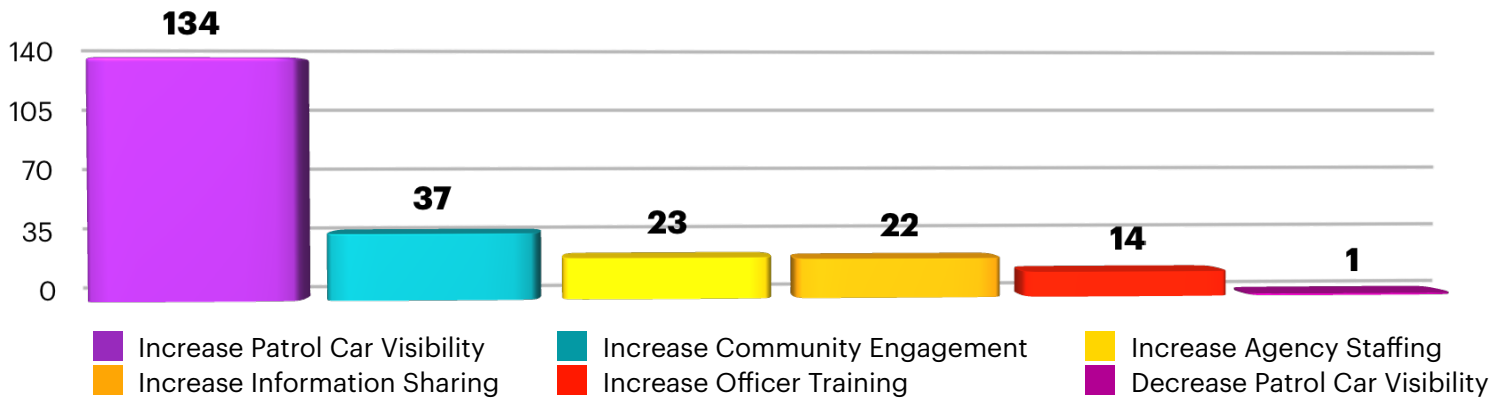

View of agency by Race/Ethnicity

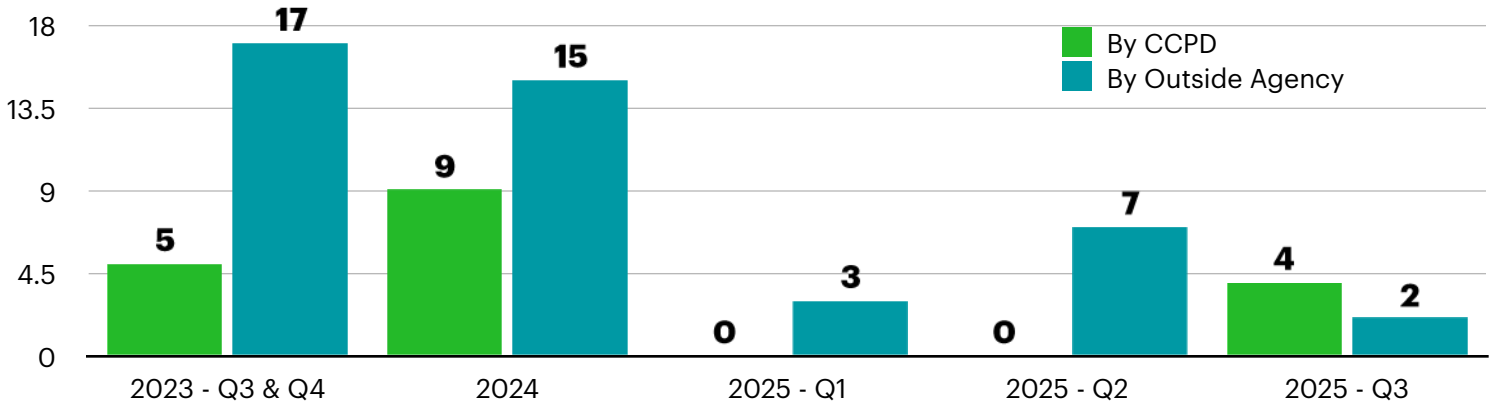

Top safety concern in your communityWhat would you most like Culver City PD do to improve safety in your community?

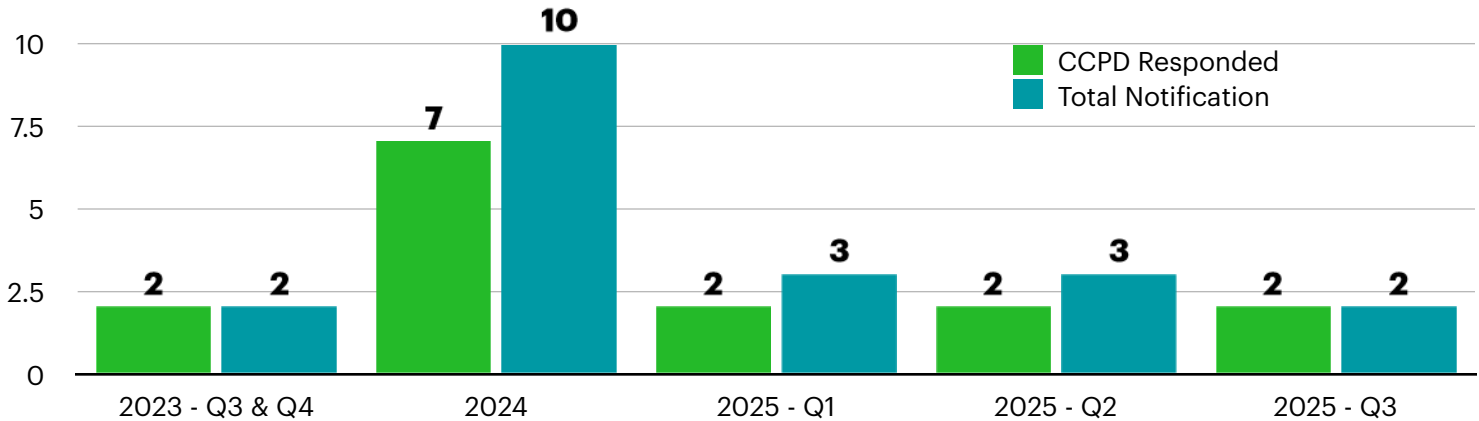
## **Mutual Aid Activity - Q3**
